- It is **vital** that you submit using the Expression of Interest (EOI) number **E0026340161**. You will not be able to proceed using a different EOI number.
- The invitation is on the basis that you have a genuine intention to live and work in South Australia with a view to long-term settlement in the state. Please ensure you're aware of this before applying for State Nomination. **(Please note South Australia does not grant release letters to other jurisdictions)**
- Applicants may only have one active application. If you have an active Registration of Interest (ROI) application, you will not be able to submit a State Nomination application. Please [log into your account on the Apply Portal](#) to withdraw your ROI.
- Do not apply with expired/missing documents. Failure to provide any required documents, or providing expired documents may result in a refusal without clarification or review.
